- VI. Finance Bob......\$ 16,013 There were only a few expenditures from last meeting. On the investment, we're down 25% but we have repositioned the portfolio - \$865 estimated income. Portfolio is down to \$13,400
- VII. Outdoor Californian of the Year status OCOY Laurie Morrison/Bob One submission at this time. Given short timeframe, can we extend deadline? If we only have one nominee, can we just skip voting and accept the one? Betsy would like to see us extend the deadline and have everyone on the Board make an effort. Peter, Risa, and Carrie agree with extending. Betsy we need to publish to the members that we've extended the deadline. New deadline to be determined or whatever Laurie decides. Bob will discuss further with Laurie and send e-mail blast.
- VIII. Legal issues: Remains unresolved No donations-No Awards Current status from Rob Bonta, Attorney General – coming from the raffle. Our incorporation has not been validated. Forms we hadn't submitted. We can't accept any donations. Peter - Does this tie into rewriting of bylaws? Bob doesn't think it does. We don't have copies of our IRS filings for the last six years. Bob is now the sole point of contact and is working on resolving the matter.
- IX. Retired Members new level of membership **John Williamson** One official retired member Patrick Young. When John did this, Patrick's picture fell off the page. We'll try and figure that out. Carrie said she'll call Ray Rychnovsky if he's interested in renewing at the retired level.
- X. Liability Insurance Savings **Bob** We have our insurance that we've been paying from way back when. John Williamson set us up with same company as being used by BATW. We're now saving almost \$1,100 a year.
- XI. EIC Peter/John Peter we have to decide how we're going to go forward. We had very few members participate last year. Or do we want to open it up to non-Californians? Last year there were only 15 people who submitted entries. Betsy – maybe people didn't have as many publications because of

Covid. Just offer awards for first and second place. We could reduce the amount of the awards to save money. Is this a benefit to membership? **Risa** – There wasn't fall conference and nothing so far for spring. We need to give members something. I think we should continue with the EIC. **Peter** – what about opening it up to non-California members? Do some PR to get more participation. We charge them more. Other organizations make money. **John** – The software can't do that – have different prices. When it's all done digitally it all goes to the judges. **Carrie** – we want to use this to get more members. If they want to be considered they need to join. **Betsy** – we're kind of in a crisis – how do we build our membership? **Peter** – what if we created two accounts with the software? One for members and one for non-members. **John** - If it retains membership it's a good thing overall. Just have a first and second place. And decide how we want to handle the cash awards. Even if we have to reduce the amount of money we award – shouldn't be a make or break issue.

Bob – **RECAP** we're not going to open it up and just leave it to our membership. We'll only give first and second. And decide on the cash award later. Keep the date the same as last year. Peter will write something for the newsletter.

- XII. Vachini Scholarship contest Peter/Don Nothing to add at this time. Matt has jumped in to talk to schools.
- XIII. Publicity **Betsy** Nothing new. But need to gear-up for EIC and scholarship. Do look at website from time-to-time to add to social media.

SFGate.com – Bob - They reached out to me that they are looking for writer to fill a position. Salaried. Do we want to post to our website? Looking for an outdoor writer. How do we share with members? **Bob will do and send email blast in the morning to the membership.**

- XIV. Website membership report, John Williamson Sent an updated report. We have 50 professional members. In the past month 5 members have expired memberships. Can people reach out to them?
- XV. Spring Conference Locations Anyone? Bob have received no locations. The few ones we reached out to last year. No response back. Going to reach out to Basecamp to see if they have anything. Mike Harris – we have a bad relationship with Basecamp in San Bernardino.
- XVI. Mission Statement, Tom Suggest that a committee go through and discuss. Peter – we have bylaws and you reduced to eight pages. I sent you the existing bylaws – 50-plus pages. If we do anything we should update the existing bylaws. Tom – I'm not up to doing that kind of review. Peter – who is asking for the new bylaws? Tom – one of the agencies. I'll go back and look

at the original document. **Bob** – it needs updating – whether it's still valid or not – if we're going to redo it then someone needs to get on that. Let's just leave it alone unless someone requests. But we still need a succinct Mission Statement and Tom said he's willing to do that. **Bob will review the bylaws and Peter said he'd help.**
